Implementing the VLIR-NETWORK Program approved by the Ministry of Education and Training at the Decision No.1596/QĐ-BGDĐT dated May 14th, 2015, Can Tho University formally enrolls the candidates into **the Master program in Food Technology in 2018 (English program)**.

- 1. Candidates: the candidates are citizen of Vietnam and other countries
- **2.** Admission: the candidate must satisfy the following requirements
- 2.1 Qualifications
- a. Engineers and scientists from Asia, Africa, ... must have obtained an academic Bachelor of Science degree in a discipline related to the content of the program from a recognized university, college or institute;
- b. Candidates are expected to have basic science training in at least 3 out of 4 of the following fields: (i) mathematics, statistics and physics, (ii) chemistry and biochemistry, (iii) biology and microbiology and (iv) engineering;
- c. Candidates having obtained BSc degree from a program where English is not the language of instruction need to have obtained a score of 6.0 on the IELTS test (or equivalent). Candidates have obtained an IELTS score of 5.5 can apply but they have to follow an English training to be offered by Can Tho University;
- d. Typical backgrounds are: BSc in Food Technology, BSc in Food Science and Technology, BSc in Food Science and Postharvest Technology, BSc in Food Engineering, BSc in Food Science and Engineering, BSc in Food Processing Technology, BSc in (Chemical) Engineering, BSc in Agricultural Engineering, BSc in Biotechnology.
- 2.2 Professional experience: no specific requirement
- 2.3 Good health
- 2.4 Submission of documents: on time
- 3. Recruitment

Selection via interview (by person/phone/Skype).

4. Training type and duration

Training type: a full-time program

- Training duration: 2 years
- Maximum extended duration: 4 years
- 5. Teaching language: English
- 6. Entry requirements
 - 6.1 An application form (see the template);
 - 6.2 Two certified copies of academic records of the undergraduate training program;
 - 6.3 Two certified copies of bachelor's degree;

- 6.4 One CV (see the template);
- 6.5 Health certificate (01 official certificate from an authorized hospital, which is valid within the past 3 months);
- 6.6 One certified copy of personal ID card or passport;
- 6.7 Three-photo slip (3x4 cm most recent photos, taken within the last 3 months);
- 6.8 One certified copy of the certificate of English.

7. Recruitment timing

Submission date: from the announcement to 08 August 2018.

Selection date: 25 and 26 August 2018.

Expected date of results: 19 September 2018. Expected enrollment date: 10 October 2018.

8. Entry conditions

8.1 If candidate is a foreigner

The candidate will be selected for admission by the University Selection Committee based on the results of the interview, English qualification and other requirements said in 2.1 (if needed).

8.2 If candidate is a Vietnamese

Candidate who takes the entrance examinations must have the scores of 50% the grading scale for each examination.

9. Fees

- Registration fee: 60,000 VND (= 3 USD)/candidate
- Examination fee: 120,000 VND (= 6 USD)/candidate/exam
- Tuition:

For Vietnamese candidate: in addition to tuition fees stipulated by the Vietnam Ministry of Education and Training, the candidate must pay additional training cost equivalent to 24,000,000 VND (= 1,200 USD)/course/student.

For foreign candidate: 3,600 USD/course/student (tuition fee for extended period of training is not included).
