Implementing the VLIR-NETWORK Program approved by the Ministry of Education and Training at the Decision No.1596/QĐ-BGDĐT dated May 14th, 2015, Can Tho University formally enrolls the candidates into the **Master program in Food Technology in 2020 (English program)**.

- 1. Candidates: the candidates are the citizens of Vietnam and other countries
- 2. Admission: the candidate must satisfy the following requirements

2.1 Qualifications

- a. Engineers and scientists from Asia, Africa, ... must have obtained an academic Bachelor of Science degree in a discipline related to the content of the program from a recognized university, college or institute;
- b. Candidates are expected to have basic science training in at least 3 out of 4 of the following fields: (i) mathematics, statistics, and physics, (ii) chemistry and biochemistry, (iii) biology and microbiology and (iv) engineering;
- c. Candidates having obtained BSc degree from a program where English is not the language of instruction need to have obtained a score of 6.0 on the IELTS test (or equivalent). Candidates have obtained an IELTS score of 5.5 can apply, but they have to follow an English training to be offered by Can Tho University;
- d. Typical backgrounds are BSc in Food Technology, BSc in Food Science and Technology, BSc in Food Science and Postharvest Technology, BSc in Food Engineering, BSc in Food Science and Engineering, BSc in Food Processing Technology, BSc in (Chemical) Engineering, BSc in Agricultural Engineering, BSc in Biotechnology.
 - 2.2 Professional experience: no specific requirement
- 2.3 Curriculum vitae: clear and transparent (not during a warning or disciplined period, not during criminal enforcement)
 - 2.4 Good health
 - 2.5 Submission of application with supporting documents: on time

3. Recruitment

- **3.1 For foreign candidates**: being admitted by interviewing (in person/via phone/SKYPE) or profile screening.
 - 3.2 For Vietnamese candidates: being admitted by an entrance examination.

4. Training type and duration

Training type: full-time Master program in Food Technology.

- Training duration: 2 years
- Maximum extended duration: 4 years

8. Entry conditions

8.1 For foreign candidates

The candidates will be selected for admission by the CTU Master Program Admission Council based on the results of interview, English qualification, and other requirements mentioned in 2.1.

8.2 For Vietnamese candidates

The candidates must follow an entrance examination and obtain a score of at least 5 out of 10 for each test (including priority scores, if any).

9. Fees

Registration and examination fees: 50 USD/candidate.

Tuition:

For Vietnamese candidates: in addition to tuition fees stipulated by the Vietnamese Ministry of Education and Training, the candidate will pay additional training cost in English equivalent to 1,200 USD)/program/student.

For foreign candidates: 3,600 USD/program/student (tuition fee for an extended period of training is not included).
